It has been a busy and exhausting summer featuring three big projects: a new website, the new boat ramp and KLA50. The status of each of these projects is outlined independently below. One compelling reason to move to a new website platform is the ability to distribute future newsletters via an e-mail facility included in the new platform. This will eliminate an ongoing cost for copying/stamps as well as a significant manual chore in printing, labeling, and mailing. Despite making great progress over the last five years in migrating to more e-mail distribution of the newsletter, we still have over 50 copies that have to go out by snail mail...so PLEASE, share your e-mail address with us.

Another compelling reason to share your e-mail address with us came to light in late October. One morning, I woke up to see an 8'x8' swim raft floating out by Rock Island. The forecast was for increasing southwest winds which would have driven the raft across the lake. With that in mind, I retrieved the raft and towed it to what I believed was the owner's beach. I was then able to send an e-mail to the out-of-town owner alerting them and advising them to contact their local caretaker to secure the raft. Additionally, I've also been able to send email alerts to people who inadvertently leave lights on after fall closing. KLA has had a well-managed website for years. The site has been used to post info about the lake, the organization, membership, meeting minutes, pictures, and links to important lake information. As webmaster, Joe Abbiati, has been a formidable force in keeping the site running and updated and our thanks to Joe for all his expertise and hard work.

Earlier this year, new board member, Brenda Hambleton, approached KLA about updating the site using newly available tools on a more versatile platform (Wixnet). She volunteered to create a mock-up that interested parties could review and decide if the new platform was worthwhile. The new site contains all the materials available on the old site, plus more. Importantly, the new site (because of the new platform) displays appropriately on a mobile device.

In addition to providing information, the new site/platform will eventually allow us to: 1) take electronic donations (we are being asked about this option more and more frequently), 2) push out the newsletters electronically (saving production/mailing time) and 3) allow us to have a blog page that can be easily updated by a variety of people.

# Long Awaited ..... it's here!

As mentioned on Facebook and the KLA website, the new boat ramp at the Town Beach is in! After a series of weather-related and materials-related setbacks in the spring, good weather, materials, manpower and luck came together and the new boat ramp was installed September 13-14. Many thanks go to Jeff Ward of Jeff Ward Excavation for his contribution of time and equipment to this project. Without Jeff's involvement, this project would never have been done.

There is still some asphalt needed at the top of the ramp. Projected completion of

this last part of the project is subject to contractor availability and favorable weather conditions. Happily, the gravel berm at the top of the ramp is working as designed, directing storm water runoff from Route 35 into the retaining pool and away from the beach. The newly-graded beach looks great and should hold up for the next summer season thanks to Jeff's careful engineering.

Funds for this project came from the Town of Waterford, an anonymous donor from Keoka Beach Campground and a State of Maine grant. A full accounting will be available after the asphalt installation is complete. (President's Note: "I pulled my boat recently and can attest to the fact that this ramp is awesome.")

### Water Quality

The lack of torrential rainstorms and good weather over the summer meant water quality of Maine lakes, in general, was very good. The LEA report on Keoka with 2019 data will be available in November. With the new configuration of the boat launch, we hope that the Gloeo levels might drop as there will no longer be erosion across the beach. bringing nutrients from the highway down into the lake in the vicinity of the Gloeo testing site. Keoka Lake continues to experience a lack of deep-water oxygenation, especially in the later weeks of the summer. Using a new approach to testing. LEA's Sonde boat did a systematic testing/mapping of Keoka in late July. Check the website for that report in the spring and/or watch Facebook posts for notice that is available.

#### Stream Surveys

Kim Struck has tromped the streams that feed into Keoka in an attempt to 1) look for evidence of overbanking/erosion which might affect water quality in the lake, 2) assess blockages that cause streams to change course, 3) clean up trash that has accumulated and 4) interface with those whose land borders the 10 streams that feed into Keoka. As more attention is focused on the watershed for lakes, such base-level information helps identify potential hazards and pollutants that affect the water quality.

# <u>CBI's</u>

Summer 2019 recorded 262 inspections over the 384 hours that a paid Courtesy Boat Inspector was on duty at the Town Beach boat launch. The total number of hours is down from past years in part due to the increase in hourly wage for the CBI's. There were 3 catches of plants leaving the lake (all non-invasives), but Milfoil **is** in lakes near us. All who launch and pull out boats need to be alert and Please self-inspect your boat vigilant. before entering/leaving any lake. In 2019, Eurasian Milfoil was caught going into the Sebago Lake State Park boat ramp and Variable-leafed Milfoil was caught going into Long Lake.

## Plant Patrol

While enjoying the lake, a team of volunteer Plant Patrollers are also monitoring the flora and fauna that lives in the lake. The lake has been divided into sections and each Patroller is alert to within their patrol changes area. Volunteers are always welcome to join the Plant Patrol. # 7<sup>th</sup> Annual Bud Lazott Memorial Regatta

The last Saturday in July saw the lake full of sailboats. In addition to the 'usual' Laser and Open classes, this year's regatta saw the addition of boats from four local camps (Birchrock, Fernwood Cove, Wazyiata and Wigwam) competing for the Camp Cup. Thanks to the able and exacting 'handicapping' of the boats by John O'Brien and Peter Leslie, a clear winner could be named in the nearly 'too close' to call Camp Cup finish. The winners: Camp Cup: 1<sup>st</sup> – Wigwam, 2<sup>nd</sup> – Birchrock, 3<sup>rd</sup> – Wigwam. Five boats from Keoka Lake

competed in the adult classes. The winners: Open Class – Eliza and John D'Agostino and Laser Class – Alan Struck (finally!)

Due to the increased number of boats, sailors and supporters, the event was moved from Chadbourne's Beach to Keoka Beach Campground. KLA thanks the Chadbourne family for hosting the first six years of the Regatta. Thanks also to Chris Searles and Keoka Beach Campground for welcoming the Regatta to their beach.

#### Walkers Mill Dam

Keoka Lake's water level has been very high this fall as the Keoka Dam was shut down tightly during a two-week period in mid/late October (at which time the area experienced one of the wettest Octobers on record). The water level rose from a record low to spillway height (a 2.5 foot increase) in about two weeks.

The Keoka Dam was closed to allow for the restoration of the Walkers Falls Dam on City Brook in South Waterford. This dam, owned by Bob Spencer and Geri O'Donnell, used to (in the day) retain a mill pond of about one-quarter acre. The restoration of the Walkers Mill Dam included the erecting of a concrete retaining dam behind the eighteenth (1795) and nineteenth-century dams. With this installation completed, the mill pond will return and Walkers Falls will again be a feature of South Waterford. This photo is taken from Back Street (behind Kimball's Hardware) showing the return of Walker's Falls after 30 years.



Reopened the beginning of November, the Keoka Lake Dam is now set to allow the lake water level to return to 'winter normal' levels.

#### KLA Merchandise

Point of fact: the initial milfoil infestation response to а is approximately \$15,000! It then costs thousands of dollars every year just to keep the noxious weeds in check.

Finally, as with any good organization celebrating a significant anniversary, we are undertaking a Capital Campaign to create an endowment so KLA is ready should milfoil (or any invasive) find its way into Keoka Lake. Other lakes in Maine are already infested with various varieties of milfoil. KLA has attacked the three-legged stool of Milfoil mitigation: (1) prevention (we have that in our CBI program), (2) detection (we have that in our Plant Patrol program); but we lack the resources to fund the (3) Eradication process. milfoil/invasives Eradicating is an expensive proposition - to put divers into the water can run over \$100,000. We are currently in the Quiet Phase of the KLA50 Capital Campaign. Stay tuned for information about the Public Phase coming in the spring of 2020.
